WHEREAS, Appropriation Ordinance No. 014-2018, Series of 2018 of the Municipality of Sibunag authorizing its Annual Executive Budget involving an appropriation of ₱91,128,653.00 was submitted to this Body for review pursuant to the provisions of Republic Act 7160;

WHEREAS, subject Appropriation Ordinance was found to have exceeded the Personal Services limitation, however, it reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance, subject however to some conditions;

RESOLVED, to declare Appropriation Ordinance No. 014-2018, Series of 2018 authorizing the Annual Executive Budget, for the General Fund of the Municipality of Sibunag, Province of Guimaras operative in its entirety effective as of the date fixed in Appropriation Ordinance No. 014-2018, Series of 2018 subject to the posting requirements under Section 59 of R.A. 7160 and notwithstanding the findings that the municipality has exceeded its personal services cap, the 2019 Annual Executive Budget is recommended to be declared operative subject to the following conditions:

1. The Municipality of Sibunag shall only utilize the amount being authorized in the Appropriation Ordinance pursuant to Section 319 of RA 7160.
2. The 5% LDRRM utilization shall be in accordance with the IRR of RA 10121, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Circular No. 2012-1 dated March 25, 2013. Further the Municipalitys LDRRMF must be reviewed by the office of the Civil Defense.
3. 20% Development Fund Municipality's approved Annual Investment Plan and DILG-DBM Joint Circular No. 2017-1 dated February 27, 2017.
4. 4<sup>th</sup> Tranche Salary Increase Implementation-Local Budget Circular No. 118 dated January 15, 2019.
5. Intelligence/Confidential Expenses-COA DBM-GCD-DND-JMC No. 2015-01 dated January 15, 2019.
6. GAD Plan, Local Budget Memorandum No. 77 dated May 15, 2018 shall be endorsed by the DILG.
7. Nutrition Action Plan-DILG Memorandum Circular No. 2018-42 dated March 26, 2018 must be formulated in the Philippine plan of Action for Nutrition covering the period 2017-2020.


