**RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 06-2018, SERIES OF 2018 AUTHORIZING THE ANNUAL EXECUTIVE BUDGET FOR THE GENERAL FUND OF THE MUNICIPALITY OF NUEVA VALENCIA, PROVINCE OF GUIMARAS AS OPERATIVE IN PART SUBJECT TO SOME CONDITIONS**

WHEREAS, Appropriation Ordinance No. 06-2018, Series of 2018 of the Municipality of Nueva Valencia authorizing its Annual Executive Budget involving an appropriation of ₱129,560,518.00 was submitted to this Body for review pursuant to the provisions of Republic Act 7160;

WHEREAS, subject Appropriation Ordinance was found to have exceeded the Personal Services limitation thus, it may be considered inoperative in part as of the date fixed in the Appropriation Ordinance, subject however to some other conditions;

NOW THEREFORE, on motion of Honorable David G. Gano, duly seconded by Honorable Cyril C. Beltran, Honorable Cresente P. Chavez, Jr., Honorable Josefina G. de la Cruz, Honorable Diosdado G. Gonzaga, Honorable Dan Elby C. Habaña, Honorable Rex G. Fernandez, Honorable Ma. Sheila G. Gange, Honorable Karren Kaye A. Gagnanan and Honorable Marilou S. Delumpa;

THE 8TH SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:


RESOLVED, to declare Appropriation Ordinance No. 06-2018, Series of 2018 authorizing the Annual Executive Budget for the General Fund of the Municipality of Nueva Valencia, Province of Guimaras operative in part, effective as of the date fixed in Appropriation Ordinance No. 06-2018, Series of 2018 subject to the posting requirements under Section 59 of R.A. 7160 and subject further to the following conditions:



1. The Municipality has to submit the Business Plan supporting their Local Economic Enterprise. However, the Municipality has no ordinance enacted by the Sangguniang Bayan pertaining to the creation of their Economic Enterprise as per certification dtd 2/8/2018.
  2. The 5% LDRRM utilization shall be in accordance with the IRR of RA 10121, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Circular No. 2012-1 dated March 25, 2013. Further the Municipalitys LDRRMF must be reviewed by the Office of the Civil Defense as per item 2.2.12 of LBM No. 77.
  3. 20% Development Fund Municipality's approved Annual Investment Plan and DILG-DBM Joint Circular No. 2017-1 dated February 22, 2017. Disbursement shall be in accordance with the Approved AIP.
  4. 4<sup>th</sup> Tranche Salary Increase Implementation-shall be in accordance with the provisions of Local Budget Circular No. 118 dated January 15, 2019.
  5. Intelligence/Confidential Expenses shall be in accordance with the guidelines prescribed under COA DBM-GCD-DND-JMC No. 2015-01 dated January 8, 2015
  6. GAD Plan, Local Budget Memorandum No. 77 dated May 15, 2018 shall be endorsed by the DILG.
  7. Nutrition Action Plan-DILG Memorandum Circular No. 2018-42 dated March 26, 2018 must be formulated in the Philippine Plan of Action for Nutrition covering the period 2017-2020.
- RESOLVED FURTHER, to require the Municipality of Nueva Valencia to comply the herein review findings and notify this Honorable Body of the actions taken thereon;
- RESOLVED FURTHER, to inform the Municipality of Nueva Valencia that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law.
- RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Nueva Valencia for information.
