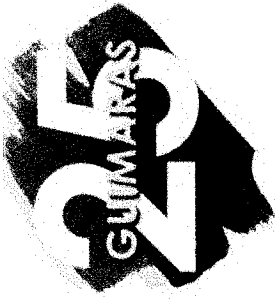

RESOLUTION AUTHORIZING GOV. SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF GUIMARAS THE MEMORANDUM OF AGREEMENT WITH THE BARANGAY COUNCIL OF BRGY. EAST VALENCIA, MUNICIPALITY OF BUENAVISTA FOR THE PROVISION OF FINANCIAL ASSISTANCE TO THE EAST VALENCIA SOFTBALL TEAM IN RELATION TO THEIR PARTICIPATION IN THE PHILIPPINE SERIES AT DUMAGUETE CITY, NEGROS ORIENTAL

WHEREAS, the East Valencia Softball Team was invited to play in the Philippine Series at Dumaguete City, Negros Oriental on April 11-14, 2019;

WHEREAS, the Honorable Governor in his letter dated April 11, 2019, requested for an authority to sign for and in behalf of the provincial government the Memorandum of Agreement with Brgy. East Valencia, Municipality of Buenavista for the provision of financial assistance in the amount of ₱159,200.00 for the East Valencia Softball Team for their participation in the said event;

WHEREAS, this Honorable Body finds the request to be in order, thereby interposing no objection on the same, subject to the terms and conditions provided in the draft MOA presented before it and disbursement of funds shall be in accordance with the usual accounting and auditing rules and regulations without prejudice to the banning period as set forth in the Omnibus Election Code.

RESOLVED, to authorize Governor Samuel T. Gumarin, MD, MPH to sign for and in behalf of the Provincial Government of Guimaras the following:

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is entered into this ____ day of ____ 2019 at the Provincial Capitol, Province of Guimaras by and between:

The Provincial Government of Guimaras, a local government unit established under existing laws of the Republic of the Philippines, with principal address at the Provincial Capitol, Brgy. San Miguel, Jordan, Guimaras, represented herein by the Provincial Governor, **THE HONORABLE SAMUEL T. GUMARIN, MD, MPH** hereinafter referred to as the First Party;

-and-

The Barangay Council of Barangay East Valencia, a local government unit established under existing laws of the Republic of the Philippines, with principal address at East Valencia, Buenavista, Guimaras, represented herein by the Punong Barangay, **THE HONORABLE LEMUEL ELIDIA**, hereinafter referred to as the Second Party;

W I T N E S S E T H

WHEREAS, under paragraph Section 16 of the Local Government Code (RA 7160), provides that: "Every local government unit shall exercise the powers expressly granted, those necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, The Province of Guimaras, being the youngest provincial component of the Western Visayas Region, is making long strides towards being at par with its co-provinces in Region VI especially in sports;

WHEREAS, Executive Order No. 55, series of 2017 was issued on October 26, 2017 to establish the Sports Development Program of the province and oversee its implementation;

WHEREAS, the East Valencia Softball Team was invited in the Philippine Series at Dumaguete City, Negros Occidental on April 11-14, 2019;

WHEREAS, the Provincial Government of Guimaras will provide financial assistance of One Hundred Fifty-Nine Thousand Two Hundred Pesos (₱159,200.00) to support the East Valencia Softball Team;

WHEREAS, an agreement must be executed between the Provincial Government of Guimaras and the Barangay Council of Barangay East Valencia for the proper utilization of the financial assistance aligned with the activity proposal as per requirement of the Commission on Audit;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto have agreed to enter into this Memorandum of Agreement under the following terms and conditions:

1.0 The PROVINCE shall:

- 1.1 Release the financial assistance in the amount of **One Hundred Fifty-Nine Thousand Two Hundred Pesos (P159,200.00)** to the SECOND PARTY for the East Valencia Softball Team to defray their expenses during the Philippine Series at Dumaguete City, Negros Occidental;
- 1.2 Ensure the compliance of documentary requirements from the SECOND PARTY for the liquidation of the fund transferred.

2.0 The BARANGAY COUNCIL OF BARANGAY SALVACION shall:

- 2.1 Submit a letter of intent and activity proposal to the FIRST PARTY;
- 2.2 Undertake the immediate implementation of the activity as represented in the approved project proposal upon release of fund by the FIRST PARTY;
- 2.3 Submit a liquidation report with supporting documents to the FIRST PARTY, relevant to the fund released/transferred upon completion of the activity; and
- 2.4 Abide with the auditing rules and regulations relevant to this matter.

3.0 Modification/Amendment and Effectivity


- 3.1 Any amendment or modification in this agreement shall be translated in writing signed by both parties and shall form part of this agreement; and
- 3.2 The term of this agreement shall take effect immediately upon the date of signing of the **Memorandum of Agreement**.


RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Punong Barangay of East Valencia and all other concerned offices for information and appropriate action.
