RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT, THE MEMORANDUM OF AGREEMENT WITH PAGDAUG-SALUDAN FESTIVAL (TRIBU MANANGUETE) OF TIGBAUAN, ILOILO FOR THE PARTICIPATION OF THAT FESTIVAL IN THE INVITATIONAL CULTURAL PRESENTATION IN CONNECTION WITH THE 26TH MANGGAHAN FESTIVAL AND 27TH ANNIVERSARY CELEBRATION OF THIS PROVINCE

WHEREAS, one of the activities during the celebration of the 26th Manggahan Festival and 27th Anniversary Celebration of this province is the Invitational Cultural Presentation scheduled on May 21, 2019;

WHEREAS, the Pagdaug-Saludan Festival (Tribu Mananguete) of Tigbauan, Iloilo is identified as one of the participants in the said event;

WHEREAS, the Honorable Governor in his letter dated May 14, 2019 is requesting for an authority to sign for and in behalf of the Provincial Government of Guimaras, the Memorandum of Agreement with the Pagdaug-Saludan Festival (Tribu Mananguete) of Tigbauan, Iloilo for the participation of that Festival in the Invitational Cultural Presentation;

WHEREAS, this Honorable Body interposes no objection to the request, subject to the terms, conditions and stipulations set forth in the draft Memorandum of Agreement presented before it and disbursement of funds shall be subject to the usual accounting and auditing procedures;



NOW THEREFORE, on motion of Honorable Cyril C. Beltran, Chairperson, Committee on Tourism, duly seconded by Honorable Diosdado G. Gonzaga, Honorable Josefina G. de la Cruz, Honorable Rex G. Fernandez, Honorable Ma. Sheila G. Gange, Honorable Karren Kaye A. Gadnanan and Honorable Marilou S. Delumpa;

THE 8TH SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to authorize Gov. Samuel T. Gumarin, MD, MPH to sign for and in behalf of the provincial government, the following:

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement entered by and between:

The Provincial Government of Guimaras represented by **HON. SAMUEL T. GUMARIN, MD, MPH**, with office address at San Miguel, Jordan, Guimaras, Philippines referred hereinafter as the **FIRST PARTY**;

and

Pagdaug-Saludan Festival (Tribu Mananguete) of Tigbauan, Iloilo, represented by **ATTY. SUZETTE T. ALQUISADA**, Municipal Mayor with office address at Tejero St., Tigbauan, Iloilo referred hereinafter as the **SECOND PARTY**;

WITNESSETH:

WHEREAS, the Provincial Government of Guimaras (PGG) will be celebrating its 2019 Manggahan Festival and 27th Anniversary Celebration of Provincehood on May 11-22, 2019.

WHEREAS, festivals from different cities and provinces in the country are invited to showcase their rich culture and history for Guimarasnons to experience through the Invitational Cultural Presentation.

WHEREAS, the Invitational Cultural Presentation is scheduled on May 21, 2019, 1 to 4 p.m. at the three (3) selected areas as part of the said grand celebration.

WHEREAS, Pagdaug-Saludan Festival (Tribu Mananguete) of Tigbauan, Iloilo was identified as one of the groups to perform for the said event featuring not only the city's colorful culture and tradition, but also the exceptional traits of its locals.

WHEREAS, the said festival signified their intent to join the Invitational Cultural Presentation.

WHEREAS, The **FIRST PARTY** which is the Provincial Government of Guimaras (PGG):

- Provides Financial Assistance of Php100, 000.00 and download the money to the second party.
- Provides billeting schools for the delegates and accommodation for the support staff with the maximum of 4 persons per tribe.
- Provides a team to assist the hubon on their needs in the duration of their stay in the island.

- Assign police and rescue team at the billeting area and in the performance areas to ensure the security and safety of the delegates.
- Provides two (2) jeeps and one (1) truck for the hauling of props, drums and contingents on their arrival and departure from the island.
- Coordinates with pump boats and RoRo for the convenient transport of the delegates.
- Requires the submission of the copy of liquidation report by the **SECOND PARTY** one month after the activity.

WHEREAS, the **SECOND PARTY** which is the Pagdaug-Saludan Festival:


- Performs in the three (3) designated areas on May 21, 2019, 1 to 4 p.m. during the 2019 Manggahan Festival: Invitational Cultural Presentation
- Shoulders the expenses to be incurred like the food of the delegation, transportation outside the Province of Guimaras, and the other needs of the Hubon.
- Coordinates with the team provided by the **FIRST PARTY** on any matters arising while in the Province of Guimaras.
- Coordinates with the sound system provided at the designated performance area on the technical requirements (number of microphones, mixer adjustments and others as needed.)
- Submit the copy of liquidation report to the **FIRST PARTY** one month after the conduct of the activity as per COA Guideline to comply with the requirements of Section 3.1.3 of COA Circular 2012-001, particularly on the required liquidation of fund transfer to include submission of the following to the provincial government:
 - a. Report of Checks Issued and Report of Disbursements certified correct by the Municipal Accountant, approved by Municipal Mayor and duly audited by the Auditor of the Municipal Government;
 - b. Copy of Credit Notice issued by the Auditor of the Municipal Government ; and
 - c. Copy of OR issued for the refund of unexpected /unutilized balance of fund transfer.

RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Pagdaug-Saludan (Tribu Mananguete) of Tigbauan, Iloilo and all other concerned offices for information and appropriate action.
