RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF UNDERSTANDING WITH MENDEL UNIVERSITY IN BRNO IN CONNECTION WITH THE PREPARATION DEVELOPMENT PLAN OF THE PROVINCIAL TREE PARK

WHEREAS, the Honorable Governor in his letter dated May 8, 2019 has requested for an authority to sign for and in behalf of the provincial government the Memorandum of Understanding with Mendel University in Brno as represented by Prof. Inq. Danuše Nerudová, Ph.D., Rector, Zemědělská 1665/1, 61300 Brno-sever-Černá Pole, Czech Republic in connection with the preparation of the development plan of the Provincial Tree Park;

WHEREAS, for the purpose of furthering cooperation in education, academic research and regional development, the provincial government and the Rector of Mendel University in Brno will be entering into a Memorandum of Understanding to affirm their intent on promoting an academic and technical exchange as reflected in the Memorandum of Understanding drafted for the purpose;

WHEREAS, this Honorable Body interposes no objection to the request, on the terms, conditions and stipulations set forth on the draft Memorandum of Understanding presented before it;

RESOLVED; to authorize Governor Samuel T. Gumarin, MD, MPH to sign for and in behalf of the Provincial Government, the following:

MEMORANDUM OF UNDERSTANDING
Between Province of Guimaras and Mendel University in Brno

The Governor of the Province of Guimaras and the Rector of Mendel University in Brno, for the purpose of furthering cooperation in education, academic research and regional development, hereby, affirm their intent into promoting such an academic and technical exchange as will be of mutual benefit for their respective organizations. Academic and technical exchange is considered here to include but not be limited to:

- Cooperation research activities;
- Provision of technical assistance for the first party in the formulation of eco-tourism development of plan for the Provincial Tree Park;
- Exchange of students;
- Exchange of scientific materials, publications and information;
- Other activities as agreed upon by both parties related to this undertaking;
- For the first party to provide data to the second party necessary for the plan preparation of the Provincial Tree Park Development Plan which will be confidential in nature;

Details of the implementation of any particular exchange resulting from this agreement shall be negotiated between the two institutions as such specific case may arise.
No financial obligation is presupposed on either party.


This agreement shall be in effect for five years, at which time it will be reviewed for possible extension. This agreement may be subject to revision from time to time by mutual agreement. Either party may terminate the agreement by written notification signed by the appropriate official of the institution initiating the notice. Notification of termination should be received by the other party at least six months prior to the effective date of termination, although it is assumed that such action would only be taken after mutual consultation in order to avoid any possible inconvenience to the other party.


RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Mendel University in Brno, and all other concerned agencies for information and appropriate action.
