RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO ISSUE A SPECIAL POWER OF ATTORNEY IN FAVOR OF MRS. EILEEN G. VALDEVIESO, ASSISTANT PROVINCIAL ASSESSOR TO PROCESS THE TRANSFER OF TITLE OF PARCELS OF LAND INTENDED FOR THE SANITARY LANDFILL

WHEREAS, the provincial government in its desire to purchase parcels of land for the proposed Sanitary Landfill in compliance with RA 9003 otherwise known as “*An Act Providing for an Ecological Solid Waste Management Program, Creating the Necessary Institutional Mechanisms and Incentives, Declaring Certain Acts Prohibited and Providing Penalties, Appropriating Funds Therefor, and Other Purposes*” was able to transact and negotiate with the owners of the property located at Brgy. Sapal, San Lorenzo to be utilized for the proposed Sanitary Landfill” after having been convinced that the subject lots have qualified and being recommended by concerned government agencies;

WHEREAS, this Honorable Body has passed Resolution No. 163 entitled: “Resolution Authorizing Governor Samuel T. Gumarin, MD, MPH to sign for and in behalf of the Provincial Government The Deed Of Absolute Sale for the Acquisition of two lots (10 Hectares) to be used as the Sanitary Land Fill under the names of Ms. Estrella Quanco for Lot No. 4443-C and Ms. Erna Alonzo for Lot No. 4443-D;

WHEREAS, the Honorable Governor in his letter dated June 10, 2019 is requesting for an authority to issue a Special Power of Attorney (SPA) in favor of Ms. Eileen G. Valdevieso, Asst. Provincial Assessor to process the transfer of title of the said parcels of land to the provincial government;

KNOW ALL MEN BY THESE PRESENTS:

That I, **SAMUEL T. GUMARIN** Governor Province of Guimaras, of legal age, married, Filipino, a resident of Brgy. McLain, Buenavista, Guimaras Philippines, have **named, constituted and appointed**, and by these presents do **name, constitute and appoint EILEEN G. VALDEVIESO**, Assistant Provincial Assessor of the Province of Guimaras, Filipino, and a resident of Brgy. Poblacion, Nueva Valencia Guimaras Philippines, to be my true and lawful **Attorney-In-Fact**, for me and in my name, place, stead, to do and perform any or all of the following acts or things, namely:

To represent in my behalf in the Bureau of Internal Revenue (BIR) Iloilo, Registry of Deeds Province Of Iloilo and Guimaras, The Provincial Assessors of Guimaras, The Department of Agrarian Reform (DAR) Guimaras and Regional office and other concerned agencies for the processing of the transfer of Title in the name of the Province of Guimaras of the following:

- (1) **Lot No. 4443-C covered KOT Blg. 2016000399** registered in the name of Estrella Quanico with an area of Fifty Thousand (50,000 sqm.) square meters more or less situated at Sapal, San Lorenzo, Guimaras;
- (2) **Lot No. 4443-D covered by KOT No. 201600097** registered in the name of Erna Alonso with an area of Fifty Thousand (50,000sqm.) square meters more or less situated at Sapal, San Lorenzo, Guimaras.

To process, sign, execute payments and acknowledge for, and in my behalf, documents and other writings to be executed that might be necessary;

To do and perform such other acts necessary to carry out the above-conferred powers.


